USE

The diluted solution should be applied to the surface to be cleaned using a spray bottle or mop & bucket. The following ratios are suggested:

Light Cleaning:	50-1
Standard/Medium Cleaning:	20-1
Heavy Cleaning:	10-1
Spray/Wipe Cleaning:	5-1
